## How to donate to DSG from the USA

**As of 1 January 2021**

To ensure that our current and future USA donors still have a tax-efficient way of donating to DSG, we have been able to secure the use of the Rhodes University Trust USA, their 501 (c) (3) trust in America, so that our donors may still take advantage of the tax benefits provided to USA taxpayers while continuing to contribute to DSG.

### **The Rhodes University Trust USA**

**The Rhodes University Trust USA** (a tax-exempt, non-profit organization) was set up in 1992 and became fully operational in 1993. Its primary purpose is to provide funding and support for educational activities conducted by Rhodes University in South Africa and other educational institutions and initiatives in the surrounding area.

The Rhodes University Trust USA is managed by a board of trustees, all of whom have volunteered their services and time free of charge. The board, at all times, consists of at least three people – the President, Treasurer and Secretary. It meets approximately once a quarter to discuss strategy, disbursement of funds and other matters of business.

The Rhodes University Trust USA will accept both electronic transfers and online donations to DSG via their established procedures, and these gifts will be transferred to us in due course.
